The LCA is available for public inspection at **Tata Elxsi Limited: 2701 Troy Center Drive Suite 125, Troy, Michigan 48084**. Complaints alleging misrepresentation of material facts in the Labor Condition Application and/or failure to comply with the terms of the Labor Condition Application may be filed with any office of the Wage and Hour Division of the United States Department of Labor.

This notice may be reposted pursuant to USCIS Guidelines (Efren Hernandez Letter issued October 23, 2003), confirming that an amended I-129 is not necessary where an H-1B employee is being moved to a location where a Labor Condition Application is in place. Where a proposed worksite falls within the same “area of intended employment,” as defined at 20 CFR § 656.3, as the previous worksite, a new Labor Condition Application is not required. The employer needs only re-post the Notice of Filing at the new worksite.
